## Narrative Report

## 1) List your goal(s) and objectives as it appears in your strategic and implementation plan. What and how did you revise the objectives due to COVID-19 and the US Census Bureau's operational adjustments?

The initial goals and objectives of the San Bernardino County Superintendent of Schools (SBCSS) as it appears in our strategic and implementation plan were to:

- Commit efforts to Census 2020 education and outreach activities to K-12 stakeholders and engage K-12 populations to motivate and activate students, parents, and families in the Census 2020.
  - SBCSS will promote and work with school districts to conduct a Census 2020 Week (March 23-April 9, 2020) at their school sites/campuses throughout the county. SBCSS identified March 30-April 3, 2020, as the best timeframe to conduct a Census 2020 Week due to most school districts on spring break during the week of April 4-9, 2020.
- SBCSS will promote Census 2020 education and outreach efforts by leveraging existing networks, such as the Content, Literacy, Inquiry, Citizenship (CLIC) Project, our Countywide Family Engagement Network (FEN), and a multitude of many other students, family, and educator programs and events.
- SBCSS will provide a trusted environment for parents and families and the public to complete the Census 2020 questionnaire at three of our regional administrative sites. Each regional location in the Desert/Mountain, East Valley, and West End area has several hard-to-count locations within proximity of the kiosks. Hours of operations from 8:00 a.m. to 4:00 p.m., Monday through Friday at the following sites:
  - Roy C Hill Education Center, 601 North E Street, San Bernardino, CA 92415

- Desert/Mountain Educational Service Center, 17800 Highway 18, Apple Valley, CA 92307
- West End Educational Service Center, 8265 Aspen Avenue, Rancho Cucamonga, CA 91730
- SBCSS will use SwORD Tier II data for our outreach efforts to identify which schools are located near Census tracks with a(n):
  - Hard-to-Count (HTC) index greater than 46,
  - High Limited English-speaking households greater than 6.9 percent, which is above the countywide average, and
  - Income below 150 percent of the poverty level greater than 29.4 percent which is above the countywide average.
- Collaborate with additional networks to include English Language Development (ELD), Math, Homeless Education, Foster Youth, and Advancement Via Individual Determination (AVID) for targeted outreach efforts.
- An invitation to attend planned activities/events extended to members of the Inland Empire Complete Count Committee/Subcommittee.

In September 2019, SBCSS sent two representatives to the Train-the-Trainer Census Curriculum trainings to help support our teachers with the implementation of the curriculum in the classroom. In addition, the writers of the curricula trained 16 San Bernardino County and Riverside County teachers and administrators to further support the implementation. During the September 28, Family and Community Engagement Summit, where approximately 500 attendees participated in the welcome provided by County Superintendent Ted Alejandre who stressed the importance of a complete count. Families, caregivers, and children gathered information, flyers, resources, asked questions, and viewed videos in English and Spanish at the hosted resource booth. Additionally, participants attended a Census 2020 workshop, co-facilitated by U.S. Census Bureau Representative, Lupe Camacho.

Beginning October 2019, SBCSS launched additional Census 2020 promotional efforts to help raise awareness, provide education, and outreach activities to K-12 stakeholders, and engage the K-12 population by activating a dedicated page on the SBCSS website. The website contained Census 2020 resources, collateral, and a video message from our County Superintendent, Ted Alejandre, on the importance of a complete count, its impact on Congressional representation, and a potential loss of approximately 19.4 billion dollars in federal funding with a potential undercount. The San Bernardino County Board of Education adopted the Census 2020 Resolution in support of the importance of the U.S. Census and commitment to help ensure a complete, fair, and accurate count of all Californians with a focus on hardest-to-count individuals. Also, SBCSS designed a display case for visitors at the Roy C Hill Education Center which included various videos about the Census in English and Spanish and posted information on how to complete the Census.

In February 2020, in partnership with the support of our local labor union organizations which included the California School Employees Association Chapter 633, San Bernardino County Teachers Association, and Teamsters Local 1932, SBCSS sent a letter and a San Bernardino County "I Count" Census 2020 custom-made button to all SBCSS staff to encourage them to support and promote the Census outreach efforts. In addition, several Census 2020 presentations were held throughout the county at the following meetings:

- San Bernardino County Personnel Administrators' Network Meeting (33 School Districts)
- San Bernardino County District Superintendents' Meeting (33 School Districts, 5 Community Colleges, and 2 Regional Occupational Programs)
- SBCSS Full Cabinet, Management and Confidential Team, and Classified Team Meetings
- Family Engagement Network
- John Almarode Teacher Training
- CLIC Region 10 Meeting (SBCSS purchased 160 books, "Clarity for Learning," to support teachers, coaches, teachers on assignment, administrators, and paraeducators with the implementation of the Census 2020 curriculum in grades 5, 8, 11, and 12. Note: SBCSS offered and covered substitute costs up to \$125 per teacher registered.)

SBCSS, in partnership with the California Census 2020 Office – Data and Geographic Information System (GIS) Mapping, identified 142 schools countywide which were located within or near a census tract meeting the Education Outreach Plan criteria of a (1) HTC index greater than 46, (2) limited English-speaking households greater than 6.9 percent (county average), and (3) households with income below 150 percent of the poverty level greater than 29.4 percent (county average). Promotional kits were designed to create awareness and inform students, families, caregivers, educators, and surrounding communities about the importance of a complete count to ensure the state of California receives its fair share of federal funding. The kit contained customdesigned buttons, a 3x6 custom-designed banner in English and Spanish, pencils, erasers, rulers, printed California For All flyers, a printed California School-Based Outreach document, and a printed set of inquiry-based Census curriculum for grades 5, 8, 11, and 12. To further expand our outreach efforts, during the month of February, SBCSS provided promotional kits to 30 non-HTC sites which included 21 SBCSS-operated schools throughout the county and nine district-operated school sites for a total of 172 sites in San Bernardino County. Schools were asked to do the following:

- Display the Census 2020 vinyl banners in a high traffic area (e.g. school fence) Note: SBCSS displayed banners at each of our administrative sites
- Disseminate Census 2020 promotional items to students and staff
- Hold a Census 2020 Week on campus
- Share information from the "2020 Census: A Guide for California's School-Based Outreach" toolkit with staff to inform and promote Census 2020 Week with students, families, and caregivers
- Encourage teachers for grades 5, 8, 11, and 12 to:
  - Implement the inquiry-based Census self-contained modules (printed materials included and a link to access materials online)
  - Attend the inquiry-based Census Module training on March 23 from 8:30
    a.m. to 2:30 p.m.

Due to the global pandemic of the novel coronavirus (COVID-19), beginning March 15 through the end of the 2019-20 school year, all 33 school districts within the county had closed their school sites. SBCSS had to revise the goals and objectives outlined in our initial plan to support all aspects of the Census 2020 work for the remainder of the contract. For example, Census 2020 Week, which was scheduled to be held March 30 - April 3, had included onsite activities for staff and students. However, social media was deployed as a primary outreach strategy instead to encourage students throughout San Bernardino County to partake in their civic duty by spreading the importance of the Census through campaign poster creations, infographics, participating in live chat sessions with their teacher, and sharing the important messaging through various social media sites (see page 11). Although teachers were unable to attend the inquiry-based Census module training on March 23, the Census curriculum was offered to students remotely.

Also due to COVID-19 concerns, the launch of the Questionnaire Assistance Kiosks (QAKs) was not activated as SBCSS closed all offices including the QAK locations referenced in our goals and objectives to provide the public a site near HTC Census tracks to complete the Census from March 12 - April 27. Although this objective and goal had not been met, SBCSS had completed all preparations including collaborating with our internal Technology Services Branch to ensure a safe and secure laptop connection to the Census 2020 survey, purchasing kiosk desks with side barriers providing privacy, preparing Census 2020 branded feathered flags and sandwich boards ready for display, and planning for the utilization of the QAK in a Box issued by the CA Census Office at our regional QAK locations.

SBCSS continued to participate in the Inland Empire Complete Count Education, Recruitment, and Training Subcommittee virtual meetings, the CA Census Region 7: Regional Calls, and the County Office of Education Zoom meetings. These forums allowed SBCSS to keep apprised of the innovative work taking place to support the Census in response to COVID-19 and informed our revised social media outreach efforts.

Additionally, on July 17, 2020, the California Department of Public Health (CDPH) released comprehensive guidance on the safe reopening of schools for the 2020-21 academic year requiring the implementation of a distance learning model. While there had been additional guidance released by state and county health officials that provided a waiver for elementary schools wanting to reopen school campuses with inperson instruction as well as campuses wishing to serve small cohorts of students on campus, additional outreach opportunities were not possible before the September 30 deadline.

Because of our existing partnerships with various stakeholders, SBCSS partnered with Families in Schools, a nonprofit serving Los Angeles County, to launch a bi-county #AllChildrenCount and #SBCSSCounts video challenge from July 28, 2020, through September 3, 2020. The video challenge asked participants to post a video of why the 2020 Census matters to them and why it's crucial to get counted. Both organizations collaborated on the social media campaign which including and providing information to the public on the importance of completing the Census, what our communities stand to lose and offering step-by-step instructions on how to take it. The video and all electronic collateral were produced in English and Spanish (see page 11).

In September, SBCSS launched another Census 2020 Promotional Kit using the GIS data shared by the Census 2020 Regional Program Manager – Southern California Lead, Quintilia Avila, who shared the latest self-response datasheets identifying up-to-date HTC areas. SBCSS deployed Census 2020 tote bags, hand-sanitizers, face masks, and California For All Census flyers that were dispersed at existing Grab 'n' Go universal meal distribution sites near high HTC areas to promote the Census. Another example of how SBCSS maximized opportunities for outreach and dissemination of additional Census 2020 promotional items during the NRFU stage included a partnership with Assembly Member Eloise Goméz Reyes and the Community Action Partnership of San Bernardino to provide thousands of Census 2020 promotional items, such as rulers and erasers to be distributed at their Census 2020 Food and School Supplies giveaway event held at San Bernardino Valley College (see page 11).

To continue sharing information about the Census, SBCSS posted various virtual events, live readings, and infographics via social media sites until the last day Census would be counted, October 15, 2020 (see page 11). Although COVID-19 altered some of our original plans, SBCSS was able to pivot efforts using a modified approach.

2) Reflecting on your own operations and outreach strategies throughout the campaign, please provide a response with specific examples for the following questions. Please also indicate which timeframe you are referring to in your response (i.e., education, NRFU period).

#### Contracted partner's operations

SBCSS did not contract with other partners; however, when the opportunity to support the K-12 population arose, SBCSS did participate. For example, during the education period, our office attended Congressman Pete Aguilar's Census 2020 briefing municipalities in both Riverside and San Bernardino Counties in December 2019, which convened at our Dorothy Ingraham Learning Center administrative site. At this convening, two local community-based organizations in attendance were contracted partners with San Bernardino County government, the Warehouse Workers Resource Center, and El Sol, who shared information and raised awareness on their planned Census activities.

As mentioned in Question 1, SBCSS had collaborated with Families in Schools, a nonprofit organization, and a subcontracted partner with Los Angeles County, to launch a Census 2020 Video Challenge on Social Media. This effort was done during the NRFU stage (July).

#### What worked well operationally?

In San Bernardino County, we have the Countywide Vision with a regional goal of supporting every child from cradle to career. This effort has been key in engaging all sectors through informed decision-making, and a collective impact approach to serving our most vulnerable students and families. Our county has been on the cutting edge of developing forward-thinking collective approaches and broad range solutions which made it feasible operationally to target outreach in the HTC K-12 populations served within the county through the various established networks.

This allowed reach into the school districts and school sites, reducing the duplication of operational efforts promoting the importance of a complete count working within our respective boundaries. Through these networks, relationships, and partnerships, SBCSS was able to leverage existing opportunities, such as:

- Making presentations at existing meetings to communicate Census 2020 information and the importance of a complete count to a variety of stakeholders,
- Partnering with school districts and SBCSS operated school sites to provide Census Promotional Kits to schools (pre-COVID-19) and existing 'Grab 'n' Go' meal distribution sites (post-COVID-19),
- o Launching the Census 2020 Video Challenge, and
- Partnering with Assembly Member Eloise Goméz Reyes and other agencies to provide Census 2020 items during their Food and School Supplies distribution.

Another notable mention related to what worked well operationally was the tremendous in-kind support our organization provided to the Education Support Services and Intergovernmental Relations department to fulfill the goals and objectives in our outreach plan. The SBCSS Business Services Branch was essential to our outreach efforts by awarding the Census 2020 budget with the full funding our office was contracted to receive for this project. This allowed us to make the appropriate expenditures needed for outreach efforts before funding was received and processing all expenditures. As we worked through the self-response deadline changes, SBCSS staff assembled hundreds of promotional kits for distribution to districts and was critical to operations. Our Procurement and Warehouse Services department worked expeditiously to approve requisitions to acquire Census products and coordinating the delivery of the promotional kits to school districts and school sites, hanging Census banners at administrative sites, and preparing the setup of QAKs. Also, our Technology Services Branch was instrumental in ensuring a secure and trusted internet connection for members of the public to complete the Census. The Communications and Multi-Media Services departments were vital to our social media campaign alerts and San Bernardino County custom-designed Census products. Our Education Support Services Branch worked vigorously with teachers to implement and support the Census curriculum. The Alliance for Education department promoted the 'Be A Census Hero -Census 2020 Matters' and 'Be Counted – Census 2020 Matters'' Twitter campaigns to encourage students to make a positive impact on their future during remote learning. This internal operational support was monumental to every aspect of SBCSS's outreach efforts. Additionally, implementing an outreach plan informed and driven by data to identify the HTC areas within our county helped focus our funding to maximize outreach efforts given our geographic size.

Engaging and participating in the Inland Empire Complete Count Education, Training, and Recruitment Subcommittee (IECC-ETR), the Region 7 Committee, and the County Office of Education meetings were beneficial operationally as it allowed our office to keep a pulse on activities taking place in various regions of the state, county, and

municipalities which helped us complement and not duplicate efforts. Also, we appreciated the opportunity to extend the contract with the Census 2020 Office to conduct additional efforts was beneficial to allow additional time for outreach needed in the HTC areas within our county, especially amid school closures.

#### What hindered the operations?

Operations were hindered by the COVID-19 pandemic. Our initial plan was to be able to raise awareness by physically attending various events, meetings, and workshops. Even though we were able to meet many of our goals and objectives identified in the Education Outreach Plan, the use of social media became our new platform and substitute to fulfill our education and outreach efforts. Providing Census Promotional Kits to students at school sites turned into providing items during universal meal distribution near HTC Census tracks. All in-person activities such as the activation of our three regional QAK's, the inquiry-based Census module training, Census 2020 Week (on school grounds) were canceled. SBCSS was unable to collaborate with the AVID network. Additionally, the amount of time allotted for the first round of promotional items to be dispersed to students was impacted by school closures. Furthermore, the self-response deadline changes impacted our operational efforts.

#### <u>Contracted partner's outreach</u> What outreach tactics worked well? What hindered the outreach?

SBCSS did not contract out with other partners.

## 3) Describe challenges and changes occurring outside or within your organization / agency that had an impact on the outreach work. Describe how you responded to these changes to work toward achieving a complete count.

Some of the challenges and changes occurring outside of our organization were related to the deadline to self-respond. With school closures throughout the county, SBCSS had to adjust operations to accommodate the self-response deadline. However, using the GIS mapping data, we were able to easily identify the areas within the educational community that had a low self-response rate and partner with the respective districts to complement our Census outreach efforts with their 'Grab 'n' Go' universal meal distribution sites.

COVID-19, CDPH, and local public health guidelines, revised how we were going to achieve outreach and instead used social media and leveraged partners to engage HTC communities.

4) For county and ACBO partners, what was the county (or region's) 2010 response rate, and what was the 2020 response rate? If the response rate met and exceeded the 2010 response rate, what contributed to that? If it did not meet the 2010 response rate, what were some of the challenges for that? For other partners, please note what data you used and how you used data for your strategies. The San Bernardino County self-response rate (SSR) for 2010 was 65.3 (see Excel file). As of September 2020, the SSR was 65.4. We were able to meet and minimally exceed the 2010 rate; however, due to COVID-19 we were not able to fully implement our Education Outreach Plan to fidelity; therefore, it is unknown whether we could have had a greater impact in our community to increase our SSR.

## 5) Please describe the process and results of your partnership coordination and how it educated and motivated the hard-to-count populations to complete the Census questionnaire.

Our coordination and partnership with the California Census Office, Education Regional Manager, GIS, and Data Mapping Manager, and the Regional Program Manager assisted us in identifying the HTC areas, target school districts near HTC Census tracks and partner with other entities to provide outreach and motivate communities served by the school district.

SBCSS leveraged existing networks such as the countywide FEN, Homeless Education Program, and CLIC to educate and promote the Census. Teachers inspired students through their curriculum lessons while engaging them in civic duty sharing the information with families and caregivers to encourage a complete count. In our experience, families wanted to learn more about the Census and how they can make a difference to their community which was witnessed at the Family and Community Engagement Summit and their network meetings. Educational stakeholders were able to participate in the various virtual events SBCSS promoted through their social media campaigns.

The process of partnering with the district superintendents who had school sites located near HTC areas in our county on the coordination and dissemination of promotional kits helped to educate our K-12 population on the importance of completing the Census.

## 6) Please provide a list of key partners and describe their contributions of how they made a difference in your outreach efforts.

33 School Districts in San Bernardino County and 21 SBCSS Operated School Sites	Promoted the Census 2020 campaign by providing students, staff, and families with the Promotional Kit items SBCSS provided.
Content, Literacy, Inquiry, Citizenship (CLIC) Project	Provided a forum for SBCSS to engage the Region 10 (Riverside, Inyo, Mono, and San Bernardino Counties), history teachers, coaches, and administrators to gain the necessary tools to implement the Census curriculum addressing grades, 5, 8, 11, and 12 throughout the districts.

Inland Empire Complete Count Committee – Education, Training and Recruitment Subcommittee Region 7 Census Committee	Provided a platform to share best-practices, activities, and events taking place within San Bernardino and Riverside Counties. Provided updates on self-response tracks with the lowest SSR, which guided our efforts to partner with the schools/districts in the most need. Shared information on activities and events taking place in San Bernardino and Riverside Counties.
County Office of Education Partners	The monthly conference call hosted by the Schools and Education Outreach Sector Manager, Mignonne Pollard, Ed.D., provided a broad spectrum of the outreach taking place throughout the state of California, which offered beneficial information to our organization.
Families in Schools, Los Angeles	Provided a partnership to co-brand a Census 2020 Video Challenge (in English and Spanish) to members of the community. In addition, they offered the first 100 people who participated in the challenge a set of bilingual books to add to their home library or could be donated to a local community center or library.
SBCSS Homeless Education Program	Facilitated a connection to our most vulnerable and hardest to reach populations in our communities by providing buttons, pencils, and flyers at local shelters.
SBCSS Family Engagement Network	Served as a trusted messaging source which was instrumental in engaging our Latino community in all regions of the county. Information was disseminated at meetings pre-COVID-19 and virtually shared after the pandemic. This network helped to ease the trepidation the community had on Census data collection and encouraged families to complete the Census.

## 7) Please describe how you provided accessible and in-language outreach activities, including how you ensured equal and meaningful access to limited English proficient individuals and people with disabilities?

Using the California Department of Education demographic overview of the county's educational system, our student population consisted of 65 percent Hispanic and over 91 percent of Spanish speaking students. Therefore, SBCSS provided all Census 2020 materials and resources in English and Spanish.

With the launch of Census 2020 Promotional Kits, SBCSS was able to offer equal and meaningful access to our most vulnerable students in K-12 by providing teachers and students with disabilities and limited English proficiency with Census 2020 materials and resources in English and Spanish.

## 8) Please share a story(s) of how your work has made a difference to Census 2020 and the impact on the community. Please include images and quotes, so we can understand the narrative behind the numbers.

Through all of the collective efforts outlined in this report, all of the challenges our county and community as a whole faced with the COVID-19 pandemic, SBCSS was able to contribute to the county surpassing the 2010 self-response rate by using informed data to reach some of the most hard-to-count areas within our vastly large demographic county making a positive impact on our students, schools, and communities for the next decade.

As our County Superintendent Ted Alejandre shared throughout this endeavor, "A complete count for the 2020 Census is vital to our community's well-being and economic prosperity. Together, we can truly create history!"

#### 9) Please add any suggestions for the 2030 Census efforts, including timelines.

A suggestion would be to have the U.S. Census and California Census offices/staff continue the focus on local efforts which took place during this 2020 Census over the next ten years which leveraged existing relationships and coalitions embedded within our communities. Also, continue the practice of a dedicated Census Office and respective committees established during this campaign fostering relationships and sharing of resources. This critical work will be vital to a successful 2030 Census.

## **CENSUS 101: WHAT YOU NEED TO KNOW**

The 2020 Census is closer than you think! Here's a quick refresher of what it is and why it's essential that everyone is counted.

# Everyone counts.

The census counts every person living in the U.S. once, only once, and in the right place.



# It's about fair representation.

Every 10 years, the results of the census are used to reapportion the House of Representatives, determining how many seats each state gets.





## It's about \$675 billion.



The distribution of more than \$675 billion in federal funds, grants and support to states, counties and communities are based on census data.

That money is spent on schools, hospitals, roads, public works and other vital programs.

# It's in the constitution.

The U.S. Constitution mandates that everyone in the country be counted every 10 years. The first census was in 1790.

# It's about redistricting.

After each decade's census, state officials redraw the boundaries of the congressional and state legislative districts in their states to account for population shifts.

# Taking part is your civic duty.

Completing the census is mandatory: it's a way to participate in our democracy and say "I COUNT!"

## Census data are being used all around you.



Residents use the census to support community initiatives involving legislation, quality-of-life and consumer advocacy.

# Your privacy is protected.

It's against the law for the Census Bureau to publicly release your responses in any way that could identify you or your household.

By law, your responses cannot be used against you and can only be used to produce statistics.



Businesses use census data to decide where to build factories, offices and stores, which create jobs.

Local governments use the census for public safety and emergency preparedness.

> Real estate developers use the census to build new homes and revitalize old neighborhoods.

## The 2020 Census and Confidentiality

Your responses to the 2020 Census are safe, secure, and protected by federal law. Your answers can only be used to produce statistics—**they cannot be used against you in any way**. By law, all responses to U.S. Census Bureau household and business surveys are kept completely confidential.

### **Respond to the 2020 Census to shape the future.**

Responding to the census helps communities get the funding they need and helps businesses make data-driven decisions that grow the economy. Census data impact our daily lives, informing important decisions about funding for services and infrastructure in your community, including health care, senior centers, jobs, political representation, roads, schools, and businesses. More than \$675 billion in federal funding flows back to states and local communities each year based on census data.



#### Your census responses are safe and secure.

The Census Bureau is required by law to protect any personal information we collect and keep it strictly confidential. The Census Bureau can only use your answers to produce statistics. In fact, every Census Bureau employee takes an oath to protect your personal information for life. Your answers cannot be used for law enforcement purposes or to determine your personal eligibility for government benefits.

### By law, your responses cannot be used against you.

By law, your census responses cannot be used against you by any government agency or court in any way—not by the Federal Bureau of Investigation (FBI), not by the Central Intelligence Agency (CIA), not by the Department of Homeland Security (DHS), and not by U.S. Immigration and Customs Enforcement (ICE). The law requires the Census Bureau to keep your information confidential and use your responses only to produce statistics.



### The law is clear—no personal information can be shared.

Under Title 13 of the U.S. Code, the Census Bureau cannot release any identifiable information about individuals, households, or businesses, even to law enforcement agencies.

The law states that the information collected may only be used for statistical purposes and no other purpose.

To support historical research, Title 44 of the U.S. Code allows the National Archives and Records Administration to release census records only after 72 years.

All Census Bureau staff take a lifetime oath to protect your personal information, and any violation comes with a penalty of up to \$250,000 and/or up to 5 years in prison.



#### There are no exceptions.

The law requires the Census Bureau to keep everyone's information confidential. By law, your responses cannot be used against you by any government agency or court in any way. The Census Bureau will not share an individual's responses with immigration enforcement agencies, law enforcement agencies, or allow that information to be used to determine eligibility for government benefits. Title 13 makes it very clear that the data we collect can only be used for statistical purposes—we cannot allow it to be used for anything else, including law enforcement.

## It's your choice: you can respond securely online, by mail, or by phone.

You will have the option of responding online, by mail, or by phone. Households that don't respond in one of these ways will be visited by a census taker to collect the information in person. Regardless of how you respond, your personal information is protected by law.

## Your online responses are safe from hacking and other cyberthreats.

The Census Bureau takes strong precautions to keep online responses secure. All data submitted online are encrypted to protect personal privacy, and our cybersecurity program meets the highest and most recent standards for protecting personal information. Once the data are received, they are no longer online. From the moment the Census Bureau collects responses, our focus and legal obligation is to keep them safe.

#### We are committed to confidentiality.

At the U.S. Census Bureau, we are absolutely committed to keeping your responses confidential. This commitment means it is safe to provide your answers and know that they will only be used to paint a statistical portrait of our nation and communities.

Laws protecting personal census information have withstood challenges.

In 1982, the U.S. Supreme Court confirmed that even addresses are confidential and cannot be disclosed through legal discovery or the Freedom of Information Act (FOIA). In 2010, the U.S. Justice Department determined that the Patriot Act does not override the law that protects the confidentiality of individual census responses. No court of law can subpoena census responses.

## Every household will have the option of responding online, by mail, or by phone.

**Nearly every household** will receive an invitation to participate in the 2020 Census from either a postal worker or a census worker.

**95%** of households will receive their census invitation in the mail.

Almost 5% of households will receive their census invitation when a census taker drops it off. In these areas, the majority of households may not receive mail at their home's physical location (like households that use PO boxes or areas recently affected by natural disasters).

Less than 1% of households will be counted in person by a census taker, instead of being invited to respond on their own. We do this in very remote areas like parts of northern Maine, remote Alaska, and in select American Indian areas that ask to be counted in person.

Note: We have special procedures to count people who don't live in households, such as students living in university housing or people experiencing homelessness.





### What to Expect in the Mail

#### When it's time to respond, most households will receive an invitation in the mail.

#### Every household will have the option of responding online, by mail, or by phone.

Depending on how likely your area is to respond online, you'll receive either an invitation encouraging you to respond online or an invitation along with a paper questionnaire.

#### **Letter Invitation**

- Most areas of the country are likely to respond online, so most households will receive a letter asking you to go online to complete the census questionnaire.
- We plan on working with the U.S. Postal Service to stagger the delivery of these invitations over several days. This way we can spread out the number of users responding online, and we'll be able to serve you better if you need help over the phone.

#### Letter Invitation and Paper Questionnaire

 Areas that are less likely to respond online will receive a paper questionnaire along with their invitation. The invitation will also include information about how to respond online or by phone.

## We understand you might miss our initial letter in the mail.

- It doesn't matter which initial invitation you get or how you get it—we will follow up in person with all households that don't respond.

## What / Why

The U.S. Census is our nation's population count and happens once every 10 years.

When you complete the census form, you contribute to an accurate count, which helps determine the amount of money California will receive for early childhood education, schools, healthcare, housing, transportation and other vital programs. The population count also determines the number of seats California has in the House of Representatives.



Who

Our constitution requires everyone living in the U.S. to be counted in the census, regardless of age, race, sex and employment or citizenship status. This includes children ages 0-4, so please include them on your census form!

By law, your answers are kept confidential, are used only for producing statistics, and cannot be used against you in any way. The census form will **not** ask about your immigration status, citizenship status, or your social security number.



## When

**March 2020:** You will be mailed an invitation to complete the census form online, by phone or by mail. Please include everyone living at your address on the form, even if they are not family members.

**April 2020:** Households that haven't responded will receive a reminder postcard, and some may also receive a paper census form.

May 2020: Census workers will visit households that have not responded to make sure everyone is counted.



## How

Completing the census form is fast, simple and convenient. In about 10 minutes, you can complete the form online, by phone, on paper, or by visiting one of the Census Action Kiosks throughout the county. Dial 311 to find a kiosk near you.

The online form will be available in 13 languages, and there will be guides in 60 languages to help you complete the questions.

Dear Superintendent,

San Bernardino County Superintendent of Schools (SBCSS) is committed to education and outreach activities to inform TK-12 students, families, educators, and communities on the importance of a complete Census count on April 1 to ensure San Bernardino County receives its fair share of federal funds. More than 70 federally funded programs that benefit California, including education, use Census numbers as part of their funding formula.

For every Californian not counted during Census 2020, California is expected to lose approximately \$1,950 per person, per year, for the next 10 years in federal funding. According to the Census 2020 California Hard-to-Count Fact Sheet (San Bernardino County Region 7), 47 percent of the county's population is considered Hard -To-Count (HTC) and this equates to an estimated loss of \$19.4 billion in federal funding over a 10-year period. There is also a possibility of losing U.S. Congressional representation which will have a negative impact on California.

SBCSS, in partnership with the California Census 2020 Office, identified 142 schools countywide which are located within or near a census tract meeting the criteria of a (1) HTC index greater than 46, (2) limited English-speaking households greater than 6.9 percent (county average), and (3) households with income below 150 percent of the poverty level greater than 29.4 percent (county average).

As part of our commitment, SBCSS will:

- Provide a Census 2020 Promotional Kit to be delivered the week of February 17 to 142 school sites meeting the HTC criteria (see attachment), which will include:
  - o Census 2020 School-Based Outreach Toolkit and promotional items
  - Vinyl banner in English and Spanish
  - Materials on inquiry-based Census modules for grades 5, 8, 11, and 12 (modules are self-contained, optional training if needed)
- Offer optional training on inquiry-based Census modules in March (dates to be announced)
- Encourage schools countywide to hold a Census 2020 Week during the week of March 30-April 3 based on their spring recess schedule
- Activate Questionnaire Assistance Kiosks beginning March 12 at the following SBCSS sites:
  - o Roy C Hill Education Center, 601 North E Street, San Bernardino, 92415
  - o Desert/Mountain Educational Service Center, 17800 Highway 18, Apple Valley, 92307

## Overview

California has the top ten hardest to count counties in the United States, and school-aged children are oftentimes forgotten when their families complete the census questionnaire.

The purpose of the toolkit is to provide administrators and teachers with basic census information to help increase knowledge of the census and to encourage family of students to accurately complete the questionnaire.

California receives over \$7 billion in vital federal aid for programs that support our schools. Some of these programs serve our hardest to count populations: Special Education, English Language Learner Support and Migrant Education.

Nationwide, the census count determines the distribution of over \$675 billion for federal programs that shape our transportation systems, elderly care, hospitals and other community services.

This toolkit includes: a sample parent letter, social media posts, and talking points to engage your school community in Census 2020 participation.

Census Day is April 1, 2020. Individuals will have until July 30 to complete the census questionnaire form. Every Californian counts. Make sure California's school-aged children are counted.

#### WHAT IS IN THIS TOOLKIT?

This toolkit is a collection of communication resources, such as tips, templates, examples and timelines, designed for K-12 administrators in schools to plan and activate a successful Census 2020 campaign. The tools can be used individually or combined creatively to engage students, parents, school officials and the surrounding community.

### Talking Points

 Every ten years the U.S. Census Bureau counts every person in the U.S., and this will be the first census to rely heavily on online responses.

Verbal Communication

- The census counts everyone living in the United States, regardless of immigration status.
- The census does not ask about immigration status.
- California schools receive over \$7 billion in federal funding, which is impacted by a complete and accurate census count. Census numbers are used to allocate, monitor, and evaluate education programs.
- Participating in the 2020 Census ensures that you and your communities have fair representation. The 2020 Census will determine the number of representatives California has in the U.S. House of Representatives and the number of votes we have in the Electoral College. Census data will also be used to redraw State Assembly and Senate boundaries.
- The 2020 Census is safe and secure.
- The Census Bureau cannot release any identifiable information about individuals, households, or businesses even to law enforcement agencies. (Title 13 of the U.S. Code)
- Census information can only be released after 72 years. (Title 44 of the U.S. Code)
- All U.S. Census Bureau staff take a lifetime oath to protect your personal information, and any violations come with a penalty of up to \$250,000 and/or up to 5 years of prison.
- A Census worker will never ask for donations or money, a full social security number, any type of funds on behalf of a political party, your mother's maiden name, credit card numbers, or full bank account numbers.
- Census workers have a Census Bureau I.D. badge with name, photo, Department of Commence watermark, and date of expiration.

I am writing to share very important information about an event that will take place in Spring 2020: the U.S. Census. The census is a count of all people living in the U.S. and takes place every 10 years. It is simple and confidential to complete. For the first time, you can respond online. You will receive a unique identifying number in the mail, which will allow you to fill out the online form beginning in March 2020. It will ask questions about your household such as how many people reside in your home, date of birth, race, and sex. Here are some things you should know:

Your identity remains anonymous. Any personal information you provide on the census form is protected by law and cannot be shared with anyone or any other federal agency. Regardless of your immigration status, the information cannot be used against you or to invade the privacy of you or any members of your family.

**The Census is important.** The Census is important because it helps to decide how much federal money our schools will get over the next ten years, and how much money our state will get for our parks, neighborhood improvements, public health, transportation, and many other programs and services.

**The Census is safe.** All the data collected through the census is protected under Title 13 of the U.S. Code. Records are confidential for 72 years by law. All U.S. Census Bureau employees swear a lifetime oath to protect respondent information. The U.S. Census will never share a respondent's personal information with other government agencies. Data is only released in summary tables; no individual records are released. The penalty for wrongful disclosure is up to 5 years imprisonment and/or a fine of \$250,000.

What do you need to do? Complete the short and easy form online. If you don't have a computer at home, you can use one at a library or at a location in your community clearly identified Census Questionnaire Assistance Center.

Your kids count, so make sure to count them when you fill out the census form in Spring 2020!

Dear San Bernardino County Superintendent of Schools (SBCSS) Staff,

Please join us in getting the word out about Census 2020 to ensure students, families, and communities in San Bernardino County get their fair share of federal resources. Census numbers are used to determine funding formulas for more than 70 federally funded programs, including education, that benefit San Bernardino County and especially our most vulnerable residents.

For every Californian not counted during Census 2020, California is expected to lose approximately \$1,950 per person, per year, for the next 10 years in federal funding. According to the Census 2020 California Hard-to-Count Fact Sheet (San Bernardino County Region 7), 47 percent of the county's population is considered hard to count and this equates to an estimated loss of \$19.4 billion in federal funding over a 10-year period. There is also a possibility of losing U.S. Congressional representation which will have a negative impact on California. We can't afford to lose vital federal resources and representation that supports our children from cradle to career!

Together we count and encourage staff to:

- Share Census 2020 information with students, parents, caregivers, and the community during Census 2020 Week, March 30 through April 3.
- Contact the Intergovernmental Relations Department at <u>IGR@sbcss.net</u> or call 909.386.2947 for Census 2020 materials to distribute.
- Wear the Census 2020 "I Count" button.
