Narrative Report

1) List your goal(s) and objectives as it appears in your strategic and implementation plan. What and how did you revise the objectives due to COVID-19 and the US Census Bureau's operational adjustments?

The County's goal was to make sure everyone was aware of the 2020 Census and everyone participated.

Objectives included:

1) Market to the 'hard to count' population, through advertising and intensive public outreach, but help everyone; 2) Connect with events held throughout the County to provide information, especially on the importance of participating in the Census; 3) Utilize local knowledge to identify where find the 'hard to count' population and make contact; 4) Be there for everyone.

The Covid pandemics caused the county to completely change its outreach strategy. Public meetings and ties to events were planned for our census outreach. County policy prevented us from following through with this face to face program and we switched to more print and local radio media. We were also constantly adjusting our message as the Census Bureau repeatedly changed their dates. Although, the Census Bureau claims they counted 99% of the population in the US, up until the last day of counting we still had people calling us asking when they would get a questionnaire or a visit from a Census worker.

Describe how you responded to these changes to work toward achieving a complete count. Due to Covid County staff was highly restricted from any in person contact. Also, in the middle of the Census activities the Planning Department, where the Census program was housed) lost a staff member, who has still not been replaced. This made it very difficult for remaining staff to put a lot of time into the Census work. We put much more emphasis on print media. Fliers were sent in school lunches, water bills and through bulk mailings to PO boxes as well as print ads in Spanish and English.
- 4) For county and ACBO partners, what was the county (or region's) 2010 response rate and what was the 2020 response rate? If the response rate met and exceeded the 2010 response rate, what contributed to that? If it did not meet the 2010 response rate, what were some of the challenges for that? For other partners, please note what data you used and how you used data for your strategies. The County did not come anywhere near its 2010 self-response rate of 70.3% with a 2020 rate of 55.2%. The greatest challenge and contributing factor was the lack of questionnaires being left for households in the County and the difficulty people had trying to fill them out online without the 12-digit Census ID. Up until the very end of the Census, County staff was receiving phone calls from the community asking when they were going to get a questionnaire or a visit from a Census worker. These calls came from areas corresponding to places with the lowest response rates.

We did not have outside partnerships; however, we had a lot of local partners that stepped up when we really needed them to. This included: local schools, Inyo County and City of Bishop Public Works Departments and the County Library. These folks went above and beyond helping us get informational fliers out to our hard to reach communities.

Census Bureau needs to be more transparent as to when they will or will not be doing specific tasks such as when the questionnaires get mailed and when they will be in the community conducting door to door counts. We were never able to get clear answers to when these things were going to happen in our communities. It made it impossible to give our communities answers to when they could expect certain events.

The Census Bureau needs to start the process with people being able to do their Census questionnaire online or over the phone <u>WITHOUT</u> the 12-digit Census ID. We got a lot of calls about this. Our community members were very disappointed when they found it near impossible to navigate without it.

- Be sure to county everyone and anyone who is living with you.
- The Census does not include a question about citizenship


